# Shenandoah County School Board is Considering Changes to Policy

This past week, Gloria Carlineo, SCSB, District 3, wrote an editorial piece in the Northern Virginia Daily where she outlined an amendment that she is proposing to the trans and gender policy the school board adopted last year. Read her editorial below:

"On Nov. 6, the American voters spoke loud and clear when they elected President-elect Donald J. Trump. Many analysts have concluded that, while the economy and the illegal immigration crisis topped their concerns, voters were also concerned about "wokeness" in America, particularly transgenderism. It is widely accepted that Trump's ad on this issue was the key for his win in Pennsylvania.

Part of the reason why this issue was key to Trump's win is that most Americans understand that the science of biology, as has been understood for millennia, hasn't changed: there are only two genders. You are either born a male or a female. Gaslighters will try to argue about those who are "intersex;" but that tiny minority of people do not possess "another" gender. Instead, they possess BOTH male and female (again, the only two genders) from which they eventually choose one. It's not a whim nor a fantasy. But I believe that the bigger reason why this issue has resonated with Americans is because the Left has attempted to push their distorted agenda of sexual confusion among our most vulnerable: our children.

Every day there is another story of how this demonic ideology has been pushed in children as young as infants, promoting puberty blockers, chemical castrations and body mutilation. Even the mother of the 10-year-old whose case is currently before the U.S. Supreme Court has been quoted as saying that her child "knew" he was transgender since he was born. Ridiculous.

The many stories (and lawsuits) by the victimized children of this barbaric ideology mostly have one thing in common: except for those instances when the parent has initiated the

confusion/conversion, it has been teachers and school counselors who did so. Detransitioners talk about how the confusion leads to anxiety, depression and suicidal ideations that INCREASE after transition. This is child abuse, plain and simple. In many, if not most, of those instances the teachers/counselors promoted transgenderism without the knowledge, much less permission of the parents. This is unacceptable and I hope that those teachers and staff will someday be held personally accountable for the damage they have caused.

At the very least, school districts must pass policy that prohibits this nefarious indoctrination and intentional confusion of our children. This is why I have proposed policy that would prohibit the teaching of gender identity in Shenandoah County through grade 12. The teachers that violate this standard will be held accountable.

I'm grateful that both Gov. Glenn Youngkin and Attorney General Jason Miyares have made the eradication of this vile ideology one of their top agenda items. As recent federal court decisions (upheld by SCOTUS) have held that teachers have a Constitutional right under the First Amendment NOT to be compelled to use the preferred pronouns of a confused student, I am also proposing an amendment to our Gender Identity policy that will reflect this legal change.

Simply stated, gender identity confusion will not be promoted in Shenandoah County public schools.
